National Institute of Wind Energy (NIWE) is functioning under the aegis of Ministry of New and Renewable Energy, Govt. of India in the field of Wind Energy. NIWE plays a proactive role in the development of Wind Energy especially in Wind Resources Assessment, Testing/Type Certification of Wind Turbine Generators, Research & Development and Information & Training Services. The Institute proposes to fill up one post of Scientist 'C' on **deputation/absorption basis** in Level 11 of 7th CPC [Pay Band 3 - Rs. 15600-39100 with GP of Rs.6600 as per 6th CPC]

1. Eligibility Conditions:

Persons working under the Central Government or State Governments or Union territory Administrations or Public Sector Undertakings or agricultural universities or recognized research institutions or councils or semi-government or autonomous bodies or statutory organizations:-

- a) Holding analogous post on a regular basis in the department;
- b) 5 years regular service in the immediate lower grade pay or equivalent
- c) Having adequate background and experience relating to Wind Energy Sector and possessing qualifications as follows:

Essential:

- a) First Class Bachelor's degree in Engineering/Technology/First Class Master's Degree in Science from a recognized University/Institution.
- b) Experience: Not less than 05 [Five] years in Energy Sector, Project Management, R&D Consultancy Service/State Electricity Boards. Preference will be given for relevant experience in wind energy Sector.

Desirable:

- [a] Master's Degree in Engineering/Technology/Business Administration from a recognized University/Institution
- [b] Ph.D in the relevant field

2. Age Limit:-

The maximum age-limit of appointment by deputation shall not exceed 56 years as on the closing date of receipt of applications.

3. Regulation of pay and other terms of deputation:

Pay of the selected candidate shall be fixed in the scale of the post in accordance with rules prescribed by the Government.



4. Period of Deputation:

Period of deputation shall be initially for a period one year extendable upto 5 years or upto the age of superannuation whichever is earlier.

Application (in duplicate) only in the prescribed proforma (Annexure-I) of the eligible candidates whose services can be spared immediately on selection, together with certificate from the Forwarding Authority (in proforma Annexure –II) along with the following documents

- a. Integrity Certificate
- b. **List of major/minor penalties imposed/ 'Nil' certificate should be enclosed).**
- c. Vigilance clearance certificate.
- d. Attested photocopies of the ACRs for the last five years (2012-13 to 2016-17) (attested on each page by an officer not below the rank of an Under Secretary to the Govt. of India).
